## 1, Policy Statement

DS Connectors and Cables India Pvt Ltd is committed to the management of all type of wastes generated from its operations, in an environmentally friendly manner and in line with applicable waste management role.

## 2.PURPOSE

Waste management & proper disposal is our prime responsibility. DS Connectors and Cables India Pvt Ltd is committed towards management of all wastes, including hazardous, e-waste and solid waste. The Policy covers wastes which are generated within the Company's plants. DS Connectors and Cables India Pvt Ltd has separate policies for Plastic wastes and E-wastes. However, these are included in the present policy also for comprehensiveness. The systems adopted for waste management are based on Rules notified by the Tamilnadu Pollution Control Board (TNPCB).

#### 3.OBJECTIVES:

- Ensure that waste management is performed in accordance with all applicable waste management rules
- Minimize waste generation at source and follow 3R (Reduce, Reuse, and Recycle) principles.
- Conduct training and awareness programs for the Company's employees, contractor workers on waste management guidelines and practices.

DS Connectors and Cables India Pvt Ltd shall achieve these objectives by

- Identify and engage internal and external stakeholders (such as employees, agencies, municipal corporations, District administration, and respective TNPCB for waste management in accordance with respective rules.
- Take required technological support that promote waste Management by collaborating with: Common Storage Treatment Disposal Facility, Recyclers, waste recycling, processor etc.
- Conducting waste management training and awareness programs
